AMENDMENT OF THE CTI-CFF RULES OF PROCEDURE ON THE ACCESSION OF A NEW MEMBER PARTY

BACKGROUND

- The CTI-CFF Rules of Procedures does not provide a mechanism for a non-founding State which does not sign the Agreement to be able to signify its agreement to be legally bound by the terms of the Agreement through accession
- Having the accession instrument in the Rules of Procedures, it is hoped that without signing the Agreement, Brunei Darussalam will have legal basis to make formal decision to be a Party to the Agreement

LEGAL BASIS OF AMENDMENT TO THE RULES OF PROCEDURE

□ Rule 24 (2) of Rules of Procedure

(2) The CTI CSO may, in accordance with Rule 5 of these Rules of Procedure, make amendments to these Rules of Procedure, the Finance Regulation and Staff Regulations with the exception of Rule 5 of these Rules of Procedure.

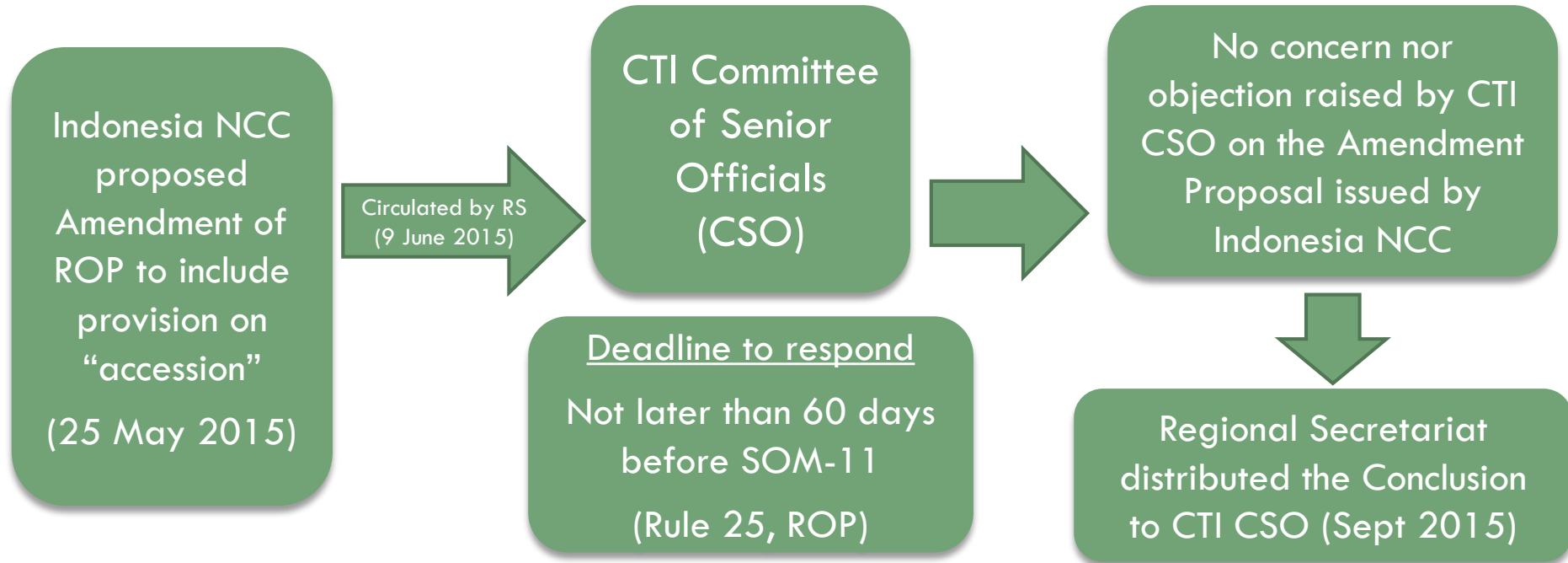
□ Rule 25 (1), (2) of Rules of Procedure

(1) Additional provisions and amendments shall be officially submitted by a Party/Parties in writing to the Executive Director.

(2) The Executive Director shall circulate the submissions to the Parties not later than sixty (60) days before the CTI COM or CTI CSO Meeting.
