2. Nowadays, Public-Private Partnership has been recognized widely as one of economic models of development in fisheries sector. However, Public-Private Partnership implementation, including design and arrangement is still challenging, as this sector is considered as a high-risk investment return for private sectors or for financial institutions;

This meeting will explore essential mechanisms and framework for Public-Private Partnership arrangement in fisheries sectors, identifying countries' potentials and challenges of Public-Private Partnership areas of development, financial mechanisms, and exchange views on building strategic plan to promote Public-Private Partnership arrangement to support development of Catch Documentation and Traceability system of seafood products for all value-chains as to increase access of local product entering national and international markets;
4. Specifically, Public-Private Partnership Preparation Meeting will have Objectives and outputs:
 - Forum to exchange views among CTI-CFF member countries to build better understanding concept of Public-Private Partnership in sustainable fisheries, including development of Public-Private Partnership arrangements.

- Encourage active participation of CTI-CFF member countries for the appropriate Public-Private Partnership arrangement of needs, including measures and actions needed to support sustainable fisheries Forum to develop Private sector cooperation for sustainable fisheries.
 - Development of fisheries information systems, such as Catch Documentation Traceability.
 - Preparation of future Public-Private Partnership meetings, and
 - List of Public-Private Partnership activities in CT6.
5. We are very happy to have CTI-CFF as a leader on Sustainable Fisheries Public-Private Partnership in Indonesia as well as in other Coral Triangle countries. There are number of Public-Private Partnership in Indonesia in many sectors that have been proceed and running. Hopefully we will have this Public-Private Partnership as the first in Sustainable Fisheries in Indonesia.
 6. We hope this meeting will produce recommendations and action plan on Public-Private Partnership for Sustainable Fisheries among Countries, engage participation of Private Sectors and Development Partners by working together to reach our planned objectives.
 7. Finally, I would like to thanks Regional Secretariat, All Delegates, all development partners, especially U.S. Agency for International Development's Regional Development Mission for Asia through U.S.
