Background:

The Coral Triangle Initiative on Coral Reefs, Fisheries, and Food Security (CTI-CFF) Regional Secretariat (RS), as part of its ongoing implementation of the Regional Plan of Action (RPOA) 2.0 (2020-2030), is currently working with the CT6 member countries in achieving their National Plan of Actions (NPOA). This support to the CT6 member countries is intended for the finalization of their respective National Plans of Action (NPOA) in alignment with Objective 3 of the Regional Plan of Action (RPOA) 2.0. The CTI-CFF Regional Secretariat in implementing the Target Outcome C1.1, which emphasizes the strengthening of the CTI-CFF Regional Secretariat's role in coordinating the implementation and monitoring of RPOA 2.0., will conduct the MEWG Online (*In-Situ*) NPOA Validation Workshop, in addressing the needs of each CT6 member country to have a uniform CTI NPOA draft.

Rationale:
